## HEARING

This matter comes before the court for sentencing.

Ms. Salvati addresses the presentence report.

Harmony Vanderhorst addresses the court.

Mr. Lloyd responds. Ms. Salvati replies. The defendant addresses the court. Sentencing ensues.

The court orders restitution in the amount of \$246, 983.71. Mr. Lloyd is to prepare a restitution order to identify each victim and the amount of restitution for that victim.

### **SENTENCE PRISON**

Based on the defendant's conviction of ISSUING BAD CHECK OR DRAFT - SUM  $\geq$  \$5000 IN 6M a 2nd Degree Felony, the defendant is sentenced to an indeterminate term of not less than one year nor more than fifteen years in the Utah State Prison.

Based on the defendant's conviction of THEFT/DECEPTION - VALUE  $\geq$  \$5000 a 2nd Degree Felony, the defendant is sentenced to an indeterminate term of not less than one year nor more than fifteen years in the Utah State Prison.

Based on the defendant's conviction of ISSUING BAD CHECK OR DRAFT - SUM  $\geq$  \$5000 IN 6M a 2nd Degree Felony, the defendant is sentenced to an indeterminate term of not less than one year nor more than fifteen years in the Utah State Prison.

Based on the defendant's conviction of THEFT - VALUE  $\geq$  \$5000 a 2nd Degree Felony, the defendant is sentenced to an indeterminate term of not less than one year nor more than fifteen years in the Utah State Prison.

Based on the defendant's conviction of THEFT - VALUE  $\geq$  \$5000 a 2nd Degree Felony, the defendant is sentenced to an indeterminate term of not less than one year nor more than fifteen years in the Utah State Prison.

To the UTAH County Sheriff: The defendant is remanded to your custody for transportation to the Utah State Prison where the defendant will be confined.

### **SENTENCE PRISON CONCURRENT/CONSECUTIVE NOTE**

The prison term is to run concurrently with each count.

### **SENTENCE RECOMMENDATION NOTE**

The amount of days for credit for time served listed in the presentence report is incorrect. The court recommends the defendant receive credit for 133 days served which is the actual number of days served on this case.
